You then have to use your cell phone to take a selfie so that they can verify your selfie to the picture on your driver's license or passport. Once you set up the online account you can access/view information including: Economic Impact Payment (EIP) history, Advance Child tax Credit Information, get transcripts, account balance, payment options/history, create a payment plan, and view notices/letters from the IRS.
